1. Call to Order/Pledge of Allegiance

Peter Ohtaki called the meeting to order at 4:32 pm and led the Pledge of Allegiance.

2. Roll Call

Jean Brook, CAC Secretary, called the roll and confirmed that a quorum was present.

3. Public Comment for Items Not on the Agenda

There were no comments.

4. New Brown Act Teleconferencing Guidelines

Julian Viksman, Legal Counsel, said that the Governor had not yet noted that the State of Emergency would be lifted and noted that no changes to the teleconferencing guidelines have been made.

Chair Barbara Arietta asked how the date May 11 is related to the March date referenced for removing restrictions. Shayna van Hoften, Legal Counsel, said May 11 was the date that President Biden was lifting the federal State of Emergency and February 28 is the proposed date that the Governor will lift the California State of Emergency. Ms. van Hoften said that legal counsel would be providing written guidance on the new teleconferencing rules to all the Boards and committees.

Regarding Item #5c, Mike Swire asked if the project expenses by category was a monthly or annual view. Jennifer Ye, Director of Accounting, said it was for the period of July through December 2022.

Regarding Item #5d, Sandra Lang asked when the investment summary that Director Beach had requested at a prior TA Board meeting would become available. Connie Mobley-Ritter, Director of Treasury, said that staff would be able to provide it in a few months. Ms. Mobley-Ritter responded to questions about the yield curve.

6. TA Board Item 6.b Approval of Minutes of the Board of Directors Meeting of January 5, 2023

There were no comments.

Dave Reed joined the meeting at 4:54 pm.

7. TA Board Item 11.a San Mateo 101 Express Lanes Quarterly Project Update

Leo Scott, Co-Project Manager, Gray-Bowen-Scott, provided the presentation.

Mr. Swire asked about the status of the US 101 Managed Lanes North of I-380 project. Mr. Scott referred the question to Heba El-Guindy, Acting Director, Program and Project Delivery. She said the Environmental Impact Report (EIR) is considering three alternatives (no build, lane convert, and lane add) and is currently in the review process, with the final report slated before the end of 2024.

Diana Bautista asked where the transponder tracker is located on the operating Express Lanes. Mr. Scott said the equipment is hung on the overhead structure and it records the number of occupants in a vehicle as transmitted by its FasTrak transponder.

Dave Reed said he had encountered zero potholes driving on US 101 north of San Carlos.

Ivan Bucio noted several unrepaired potholes on US 101 between Redwood City and East Palo Alto. Mr. Scott said to check the Caltrans website, District 4 page to find out about the work being done. Ms. El-Guindy said that the TA has been sharing information about pothole locations with Caltrans on an ongoing basis and would pass along any information.

Mr. Skinner noted that Ms. Brook would send out the weblink to contact Caltrans to report potholes.

Chair Arietta asked how the pothole repairs were monitored. Mr. Scott said emergency repairs have priority but are not designed to last 20-25 years, as opposed to other repairs that are designed to last 40-plus years.

Mr. Ohtaki asked how the system reads a traditional transponder versus the new switch transponder. Mr. Scott said the user would be charged the single occupant (full fare) rate.

8. TA Board Item 12.a Update on the Investment Portfolio and Environmental, Social, and Governance Investing Discussion by Public Trust Advisors

Connie Mobley-Ritter, Director of Treasury, provided the presentation prepared by Public Trust Advisors.

Mr. Swire asked about the scope of the Board's limitations to make changes to the TA's investments. Ms. Mobley-Ritter said the Board is limited to the State of California's investment rules. She added that while the TA has a fiduciary responsibility to invest the money safely, followed by prioritizing liquidity and return, the Board decides the parameters of the investments.

Mr. Ohtaki asked if there has been any research to compare fixed-income yields for high-grade ESD (Environmental, Social, and Governance) versus non-ESG investing. Ms. Mobley-Ritter said she would pass the question on to their investment advisors.

Mr. Swire suggested the CAC make a joint statement to support adoption of ESG.

Gus Mattammal said he did not want to adopt ESG due to its potential impact on the returns on public money.

Ms. Lang said she supported maintaining open communication with the Board about its investments.

9. TA Board Item 13 State and Federal Legislative Update

Jessica Epstein, Manager, Government and Community Affairs, provided a summary of federal and state legislation. She said at the federal level, the House committee assignments were finalized. She said the Treasury was using extraordinary measures to keep the nation solvent in light of the debt ceiling being reached.

Ms. Epstein reviewed the committee assignments at the state level. She said the Governor released his preliminary budget on January 10 and noted budget cutbacks on the horizon that would affect transportation agencies. She provided an update on Brown Act teleconferencing legislation discussions from other agencies.

Mr. Mattammal expressed concern that recent bills were micromanaging the process for obtaining transportation funding. Ms. Epstein said that the state has adopted CAPTI (Climate Action Plan for Transportation Infrastructure), and noted that projects without green elements are not likely to get funded.

Ms. Lang urged staff to have an ongoing watch of Assembly Bill (AB) 7.

Mr. Swire disagreed that the money had been used wisely in terms of the environment. Ms. Epstein said the TA is obligated to go by what the voters want, but emphasized that the upcoming Strategic Plan will reevaluate priorities. Mr. Skinner said they are not at liberty to change the program categories authorized by the voters. Ms. El-Guindy indicated that the TA team has been retrofitting projects wherever possible to include multi-modal components and mitigate impacts on the environment.

Mario Rendon left the meeting at 5:58 pm.

Mr. Ohtaki asked if there were a way to provide more predictability on transportation funding, given the State's cycle of surplus and deficits. Ms. Epstein said she did not have a good answer for that question.

10. Report of the Chair

Chair Arietta said Bay Area Toll Authority (BATA) announced that California Supreme Court has dismissed the challenges to the Bay Area Traffic Release Plan approved by Bay Area voters in 2018 through Regional Measure 3 (RM3). She said that MTC (Metropolitan Transportation Commission) is looking forward to moving quickly to unlock the RM3 funds. She said the toll revenues would be used to fund the extension of Caltrain into downtown San Francisco.

She noted that the storms from earlier in the month had revealed a lot of damages to the roadways in the form of potholes.

Ethan Mizzi asked if the DTX (Downtown Rail Extension) had been renamed "The Portal," which Mr. Skinner confirmed.

11. Report From Staff

Ms. El-Guindy said the Executive Director's report was in the Board packet. She welcomed Martin Reyes, who had joined the TA's Planning and Fund Management Department.

12. Member Comments/Requests

There were no comments.

13. Date/Time of Next Regular Meeting

Mr. Ohtaki announced that the next meeting would be held on Tuesday, February 28, 2023, at 4:30 pm via Zoom teleconference (additional location, if any, to be determined).

US 101 Express Lanes Update

The northern segment of the US 101 Express Lanes project (Whipple Ave to Interstate 380) in San Mateo County is currently open to HOV 3+ vehicles (vehicles with 3 or more passengers) and motorcycles until the toll system testing is completed. We anticipate tolling will commence in early March, creating 22-miles of Express Lanes between the San Mateo/Santa Clara County line and San Francisco International Airport in each direction. In mid-April, project supporters including federal, state, and local elected officials and leaders will be invited to a special opening event to celebrate the completed project. More information will follow.

Similar to the efforts on the southern segment, a broad public outreach campaign is scheduled to launch in coordination with the full opening of the lanes and will include e-mail blasts, updates to the Caltrans project website, social media messaging, traffic advisories on 511 and other regional websites, and press releases. A paid multi-lingual advertising effort, including radio announcements, gas station ads, and on-corridor digital billboards, will also be launched to help drivers learn how to use the lanes.

El Camino Real (ECR) complete streets project

In December of 2021, the Town of Colma was awarded \$1,800,000 of Measure W Highway Program category funds, in addition to \$200,000 local match for the City's Project Study Report-Project Development Support (PSR-PDS) Phase of the El Camino Real (ECR) complete streets project. This project will improve multi-modal infrastructure, traffic operations, and safety along El Camino Real in the Town of Colma between Albert M Teglia Boulevard to the north and Arlington Drive to the south.

After coordination between the TA, Town, and Caltrans (the owner of ECR), the PSR-PDS was officially kicked off at the end of 2022. This phase will define the purpose and need and evaluate design alternatives. Complete Street designs to be considered will include: Class IV protected bike lanes, a Class I shared-use path, sidewalk and accessibility improvements, a roundabout or a traffic signal with controlled pedestrian crossing(s) at the intersection of ECR

and Mission Road along with the addition of a traffic signal with controlled pedestrian crossing(s) at the intersection of ECR and Collins Avenue.

Menlo Park Middle Avenue Undercrossing Earmark

With the support from Congressional Representative Anna Eshoo, the City of Menlo Park secured \$4 million in community project funding (formerly known as an "earmark") for construction of the Middle Avenue Pedestrian/Bicycle Rail Crossing project. The project will ultimately include the construction of a pedestrian and bicycle-only grade separated structure (tunnel) and a mid-block crossing feature raised crosswalks, signage, and flashing beacons to provide a safe and direct connection between major Menlo Park destinations. The TA is a funding partner and has provided \$1,130,000 toward the design phase of the project from a Cycle 5 Pedestrian and Bicycle Program award. The City has now secured approximately \$13 million toward this \$20+ million project; the City will be seeking other discretionary grants and funding for the full funding of the project.

Regional Measure 3 Update

Regional Measure 3 (RM 3) was passed by 55 percent of Bay Area voters in 2018 to fund approximately \$4.5 billion of highway and transit projects from toll increases on the region's seven state-owned bridges. However, RM 3 was subsequently challenged in court and funds generated from the toll increases have been held in an escrow account. On January 25, 2023, the California Supreme Court dismissed the lawsuit and the Metropolitan transportation Commission (MTC) and the Bay Area Toll Authority (BATA) are waiting final procedural orders from the State Court of Appeal to begin the process of allocating RM3 funding. With the dismissal of the case, the Transportation Authority will have the ability to access \$50 million specifically identified in the expenditure plan for the US 101/SR 92 Area Improvements and Direct Connectors projects. MTC anticipates releasing guidelines for funding allocations in late summer 2023.
