Hi Erick,

Yes, a tragedy indeed. We take bicycle safety seriously in San Carlos, and we have been working on an update to our Holly Street exchange for some time, to include a new bicycle and pedestrian overpass over US 101.

This project has always been a high priority for San Carlos, but unfortunately we can't fully fund it independently, so the timeline is still undetermined. Our staff is working with the San Mateo County Transportation Authority (TA), City/County Association of Governments of San Mateo County (C/CAG), and the California Department of Transportation to get this project back on track.

At our last meeting we agreed to take a look at near-term temporary configurations that can help. I look forward to that discussion after our staff has had a chance to analyze.

We have also been working diligently to implement our Bicycle and Pedestrian Master Plan – see more at <https://bit.ly/3BhoZu4>.

Dear San Carlos City Council,

My name is Erick Gutierrez, and I commute by bicycle every day, covering a minimum of 8 miles round trip. I was deeply saddened and alarmed to hear about the tragic death of a bicyclist today. This incident highlights an urgent need for action to ensure the safety of vulnerable road users.

The current design of the bridge where this tragedy occurred poses a significant public hazard. Much like a fallen tree blocking the road would be immediately addressed, it is imperative that we prioritize the safety of cyclists and pedestrians who share our roadways with vehicles.

I urge the council to implement immediate safety measures, such as quick-fix solutions. These are temporary, cost-effective methods to modify road layouts and provide proper separation between vulnerable road users and motor vehicle traffic. While a permanent redesign of the bridge may take time, these interim solutions can help prevent further tragedies.

The safety of all road users must be a top priority. I hope to see swift action to address this pressing issue.

**Subject:** Inclusion of Redwood City Ferry Service and Terminal Project in Plan Bay Area 2050+

MTC Planning Committee Members and Regional Network Management Council Members:

I am writing on behalf of the San Mateo County Transportation Authority (TA) to express our concern regarding the exclusion of the Redwood City Ferry Terminal and Service Project from the Regional Transportation Plan, Plan Bay Area 2050+, which will be presented to the Planning Committee and the Regional Network Management Council on December 13, and December 16 respectively. We urge the Planning Committee and the Regional Network Management Council to reconsider this decision and require that the Redwood City Ferry Terminal and Service Project and all other San Mateo County projects (including the SamTrans Dumbarton West Connector project, a proposed busway along the Peninsula side of the Dumbarton Rail Corridor) remain in the final version of the plan.

The Redwood City Ferry Terminal and Service Project, included in previous versions of Plan Bay Area, has secured tens of millions in funding and is currently under environmental review which is scheduled to be complete in January 2026 with construction starting soon after.

The Redwood City Ferry Service and Terminal Project is funded with federal and regional funding sources that are **only** available to ferry projects (“ferry only funding”) and fills a missing link in the regional transit system by providing the only direct transit connection between the East Bay and the growing employment center in and around Redwood City, allowing residents from the East Bay to access high paying, technology based jobs.

The funding plan for the Redwood City Ferry Service and Terminal Project includes \$15 million in TA funds specifically dedicated to Ferry investments in Redwood City, a \$5 million state budget earmark, an allocation of SF Bay Ferry’s Regional Measure 3 capital funds, and expected funding from the Federal Transit Administration’s (FTA) Passenger Ferry Grant Program. All these funds can only be used to fund ferry projects and cannot be used to support other projects in Plan Bay Area 2050+.

Additionally, FTA’s Passenger Ferry Grant Program requires that proposed projects are included in the Metropolitan Planning Organization’s Regional Transportation Plan. Removing the Redwood City


Ferry Service and Terminal Project from the list of fiscally constrained projects does not make room for other projects and does not detract any funding from any other projects. Instead, it prevents SF Bay Ferry from seeking **ferry only** federal funding and reduces the amount of federal funding the region can secure. MTC should be looking for ways to increase the capacity of funding instead of taking actions to reduce it.

The Redwood City Ferry Terminal and Service Project will be a vital component of our regional transportation infrastructure as it will provide an essential east west transit link, connecting disadvantaged communities with high paying jobs and leveraging dedicated **ferry only** funding sources that benefit the entire Bay Area.

We urge this Committee and Council to require that the Redwood City Ferry Service and Terminal Project and all other San Mateo County projects (including the SamTrans Dumbarton West Connector project) remain in the final version of Plan Bay Area 2050+.

**RE: Draft 2024 Climate Action Plan for Transportation Infrastructure Actions and Descriptions**

Dear Secretary Omishakin,

The San Mateo County Transportation Authority (TA) writes to offer our perspectives and comments on the Draft 2024 Climate Action Plan for Transportation Infrastructure Actions and Descriptions (Draft CAPTI Actions). The TA plans, funds, and delivers transportation programs and projects throughout San Mateo County, including managing two voter-approved sales taxes that generate roughly \$170M in revenue per year to help improve transit and relieve congestion. As such, many of the draft actions and descriptions have the potential to impact how the TA supports multimodal transportation infrastructure in San Mateo County, with direct impacts to our constituents, interregional travel, and goods movement in the Bay Area.

The TA supports several Draft CAPTI Actions, including:

- *Development of a Statewide Express Mobility Plan.* San Mateo County has existing express lanes and can bring its experience to a working group drafting such statewide policy and planning efforts. The TA welcomes the opportunity to share our region's expertise, the results of lane management, and details about our Community Transportation Benefits Program, which subsidizes transportation costs for historically underserved and lower-income individuals.
- *Development of a prioritization methodology for climate adaptation projects currently identified in Caltrans District plans.* The 2019 Caltrans vulnerability assessment process identified climate hazards from temperature rise to changing precipitation, storm surges to sea level rise, and cliff retreat to wildfire. Adapting transportation and other related infrastructure will require tens of billions of dollars in the Bay Area alone, so we support the use of evidenced-based, cost-effective strategies to maximize outcomes with limited funding.
- *Improve VMT analysis and mitigation.* We encourage the state to evaluate how VMT analysis and mitigation is being deployed in all areas of the state. VMT growth is often a reflection of economic growth; the transportation system should support this growth while also meeting climate goals. While reducing VMT is an important goal, it's one of many goals the state, regional, and local agencies must balance with limited resources and is most effectively mitigated at the regional scale, rather than on a project-by-project basis. VMT mitigation significantly increases the costs of projects across the state.

While mitigations may include complementary investments into public transit and complete streets, the state's policy and implementation decisions impact the ability to deliver our voter-approved expenditure plans.

The TA does, however, have concerns with some of the Draft CAPTI actions. We respectfully request your consideration of our feedback, which is aligned with the perspectives of statewide organizations, including the Self-Help Counties Coalition and the California Association of Councils of Governments:

- *Updating the Trade Corridor Enhancement (TCEP) Program and the Solutions for Congested Corridors (SCCP) guidelines to elevate VMT factors in project selection.* SB1 programs should maintain the flexibility to fund projects that contribute positively to our mobility goals, even if they result in some degree of unmitigated VMT based on Caltrans' current VMT analysis methodology. Caltrans' tool for analyzing VMT mitigation does not distinguish between types of VMT (single-occupancy, carpool, zero-emission vehicle, and freight vehicles) and can overestimate VMT generated from a project. In addition to our general concerns with the increasing costs of VMT mitigation measures, we are concerned that current practice requires additional mitigation for projects that are already identified in a regional transportation plan/sustainable communities strategy that meets our climate goals. As discussed above, VMT mitigation at the regional level may be the more effective way to manage VMT, acknowledging that individual projects are a small piece of a larger transportation network that needs to meet multiple goals. VMT creation and mitigation must remain one factor among many for purposes of scoring and funding projects on the state highway system.
- *Codify CAPTI guiding principles.* CalSTA describes CAPTI as a "living" document, and we agree with its evolving nature. As such, it should remain an administrative document rather than become a rigid, statutory framework that cannot adapt to our evolving understanding of CAPTI's implementation. While we look forward to reviewing any proposal to codify CAPTI principles, we are concerned that this proposed action could give future administrations open-ended authority to adjust the state's transportation funding priorities and programs without legislative oversight, including by our elected legislative delegation. This approach could negatively impact our ability to deliver projects included in our local self-help measure expenditure plans.
